In consideration of HOTFLAME extending credit to CUSTOMER from time to time, in order to facilitate purchase of HOTFLAME'S LP gas products, the CUSTOMER agrees:

1. HOTFLAME credit terms are 30 net days for customers in good credit standing.
2. That each purchase of LP gas to CUSTOMER'S home shall be evidenced by such forms as HOTFLAME shall use from time to time, and that HOTFLAME shall maintain an account in CUSTOMER'S name (hereafter the "ACCOUNT") to which HOTFLAME may charge the cash selling price of product purchased, and a finance charge of **1.7% per month** on the unpaid balance of the ACCOUNT from month to month.
- 3. CUSTOMER MAY PAY THE FULL AMOUNT SHOWN ON HIS MONTHLY STATEMENT AND AVOID ANY FINANCE CHARGES. CUSTOMER MAY AT ANY TIME PAY THE TOTAL UNPAID BALANCE OR ANY PART OF THAT BALANCE.**
4. Upon default in payment of any installment the entire balance, at HOTFLAME'S option, may be declared due and owing. If referred for collection to an attorney not a salaried employee of HOTFLAME, CUSTOMER agrees to pay a reasonable attorney fee and court costs incurred by HOTFLAME.
5. The maximum amount of credit herein requested may be increased only in writing and duly signed on behalf of HOTFLAME.

NOTICE TO CUSTOMER: DO NOT SIGN THIS AGREEMENT BEFORE YOU READ IT OR IF IT CONTAINS ANY BLANK SPACES. YOU ARE ENTITLED TO A COPY OF THE AGREEMENT YOU SIGN.

In consideration of HOTFLAME allowing CUSTOMER the use of propane bulk tanks at the above noted address of CUSTOMER, CUSTOMER agrees:

1. That the storage tanks, regulators and all tank fittings furnished and installed shall be and remain the property of HOTFLAME GAS, INC. and that CUSTOMER acquires no title thereto, also includes blocks and 1st stage regulator.
2. All state, federal or local taxes, if any, are to be paid by CUSTOMER; In addition, labor and material will be paid by the CUSTOMER, in addition to the tank use charge of **-NO DEPOSIT FEE-** No lease fee charged when ½ tank propane purchased per year.
3. HOTFLAME agrees to keep said storage tank, regulators and tank fittings in proper repair and condition for the furnishing of LP gas service and may enter the customer's premises at any time to replace or repair them or to remove them on termination of this agreement.
4. CUSTOMER agrees that the equipment furnished and installed under this agreement is to be used only in connection with gas furnished by or through HOTFLAME. Customer shall notify HOTFLAME promptly if they do not function properly.
5. This agreement may be terminated at any time upon thirty (30 day) notice in writing by either party; upon termination, the equipment shall and may be removed without further notice.
6. Upon any default in CUSTOMER'S obligations to HOTFLAME, HOTFLAME may remove its equipment.
7. Customer subject to restocking and pick up fee if product in tank at time of pick up.
